Notice given under Section 708A(5) of the Corporations Act

This notice is given by Sunstone Metals Limited ('Sunstone') under section 708A(5)(e) of the Corporations Act in relation to an issue of 4,500,000 fully paid ordinary shares by Sunstone on the exercise of unlisted options on 3 September 2019 and 128,775,000 fully paid ordinary shares issued 10 September 2019 representing the allotment on the underwriting of the shortfall of exercised Listed Options (a further 11,250,000 shares remaining to be issued on the underwritten shortfall Options awaiting cleared funds) without disclosure to investors under Part 6D.2 of the Corporations Act.
